SUBSTRATE QUALITY

Installed Sikaplan® WT sheet membrane must be dry and clean.

APPLICATION METHOD / TOOLS

Installation according to valid Method Statement and standard detail drawing for basement and tunnel waterproofing with Sikaplan® WT sheet membranes. Spotwise heat welding of base plate onto single-layer sheet membrane, or all-around welding of base plate onto second layer of double-layer systems including membrane opening below flange. Connection of the injection hose to the flange:
